Dear Dr Almansa De Lara,

Indeed, I am aware of the publication of the referred regional Resolution in the autonomous region of Castilla y León in Spain. My services have made a preliminary study and we are deeply concerned as regards the possible effect of those rules if they are applied.

The Resolution as published is not compatible with a number of EU provisions on infection with Mycobacterium tuberculosis complex (MTBC). Those regional rules authorise movements of animals that are not allowed in EU legislation, namely in Delegated Regulations (EC) 2020/688 (¹) and 2020/689 (²). More specifically that regional Resolution derogates from certain compulsory premovement tests and/or enables movements from bovine establishments in which the infection with MTBC health status is suspended or withdrawn due to positive or doubtful test results or even possibly when outbreaks are confirmed. This kind of movement is extremely dangerous as it might facilitate further disease spread.

Furthermore, the mentioned regional Resolution appears to provide for a lax and non-compliant mechanism for restoring the status free from infection with MTBC to bovine establishments (and regions) without applying the testing regime prescribed in EU legislation.

The mentioned non-compliances with the relevant EU rules for granting, maintaining or restoring the status free from infection with MTBC may lead to a risk of infection with MTBC spread to other regions of Spain and the other Member State of the EU that will jeopardise their free status.
